# TERMS AND CONDITIONS OF ENTRY

## DEFINITIONS:

In these terms and conditions of entry the following terms will have the meanings shown:

The "Organisers" are the 1st Ibstock Scout Group – "Exhibitors" are any person(s) or organisation(s) submitting a form to the Organisers – The "Event" is the Ibstock Country Fair – The "Form" is the Priority reservation form – The "Space Charge" is the amount due for the space allocated at the rate shown on the form – The "Space" is the area allocated to the Exhibitor by the Organisers for the purpose of the exhibit – The "Site" refers to the whole area under the supervision of the Organisers of the Event.

## APPLICATIONS / ALLOCATION OF ACCESS OF SPACE:

- All applications must be made on the Form, which is obtainable from the Organisers. **The supply of a form does not constitute an offer of space.**
- The form must be completed with all relevant details by the Exhibitor (or his agent) and sent to the address shown, with the charge for space requested.
- No space can be reserved unless a Form and payment have been received.
- The submission of the Form constitutes acceptance of these conditions.
- Space is allocated at the sole discretion of the Organisers.

## USE OF SPACE / PROHIBITIONS:

- The content of the Exhibit must be as stated on the Form. The exhibit must be on view to the public, and in the charge of a responsible person while the event is open to the public.
- Exhibitors will comply with any rules or regulations made by the Organisers.
- Exhibitors will be responsible for the conduct of their staff.
- No loudspeaker, apparatus, other equipment or activity liable to cause a nuisance or annoyance to the other Exhibitors or the public will be permitted.

## CANCELLATION, POSTPONEMENT OR ABANDONMENT:

- In the case that the Event, or any part of it, is postponed or abandoned by the Organisers or, in the case of a cancellation of any licence, or other circumstances beyond their control, they shall be under no liability in respect of any loss sustained or incurred by the Exhibitor, and the Organisers shall be entitled to retain the whole or such part of all sums paid to them as they at their absolute discretion, shall deem necessary to cover expenses incurred in connection with the Event.

## INSURANCE:

- The Exhibitor will be responsible for insuring his staff and property, and take sensible precautions to guard against accident, loss or damage.
- The Exhibitor will also be responsible for the safety and conduct of his staff and visitors to the space and for his and their property.
- The Exhibitor shall not do or permit any act that may jeopardise the insurance of the Event.
- The Exhibitor will insure for Public Liability Insurance.
- The Organisers shall at no time be held responsible for the loss, damage or destruction to any exhibit or property of the Exhibitor or his staff or visitors, however caused.

## DATA PROTECTION ACT:

Information given on this form and in any other communication may in whole or part be recorded on a computer, registered under the Data Protection act of 1984. In accordance with the Act any data recorded under your name may be inspected on application to the Organisers.
